



## TERMS OF USE

These Terms of Use (“the Terms”) apply to your access to the Cannyx Markets website [www.cannyxmarkets.com](http://www.cannyxmarkets.com) and its subpages (jointly as “the Website”), which are operated by Cannyx Markets UK Ltd, with its registered seat at Alexandra House, 43 Alexandra Street, Nottingham, England, NG5 1AY, identification No: 12316918, incorporated and registered in England and Wales (“Cannyx Markets”, “we” or “us”).

By accessing the Website you acknowledge that you have read and understood the Terms, accept the Terms and agree to be bound by them. The Terms are intended for both, individuals as well as business customers.

The Terms govern your access to the Website. If you don’t agree with (or cannot comply with) the Terms, you may not access the Website.
